HEALTH AND TEMPERMENT GUARANTEE

7 Day Refund

If you change your mind about wanting to keep the puppy for any reason, return the puppy to Stellar Dobermans for a refund of your money.

The puppy you have selected is guaranteed to be healthy at the time of purchase, to the best of our knowledge. To keep this guarantee in force, you must have your puppy examined by a licensed veterinarian of your choice within seven days from the time the puppy left the care of Stellar Dobermans. During the initial exam should your veterinarian find the puppy to be in poor health that would require further vet care, return the puppy to Stellar Dobermans for a refund of your money.

If within seven days of receiving the puppy you find the puppy to have poor temperament (including aggression, fear of being touched, unprovoked nervousness), return the puppy to Stellar Dobermans for a refund of your money.

12 Month Guarantee

If your puppy dies or is crippled by Parvovirus, Distemper, Hepatitis, Leptospirosis, or any congenital defect within 12 months of purchase, return the dog, lab verification, shot record, and AKC certificate, and Stellar Dobermans will replace the dog free of charge, when another litter becomes available.

24 Month Guarantee

If your puppy dies or is crippled by dysplasia or any hereditary disease within 24 months of purchase, return the dog, lab verification/x-rays/veterinarian reports, and AKC certificate, and Stellar Dobermans will replace the dog free of charge, when another litter becomes available.

VACCINATIONS AND WORMING

I understand that my puppy has received the following vaccinations:

I understand that it is my responsibility to continue puppy immunizations under the schedule recommendation of your veterinarian from date of purchase. A common schedule of puppy vaccinations recommends boosters again at 12 weeks and 16 weeks, and the rabies vaccine is typically given at 16 weeks.

I understand that my puppy is not protected until all vaccines are received, and he or she should not be taken to dog parks or other places where my puppy can come into contact with unvaccinated pets.

ADDITIONAL PROVISIONS AND TERMS OF SALE

Stellar Dobermans mandates quality and safe homes for our puppies.

The buyer agrees to:

- ❖ Provide for the puppy's physical care, including annual physical examinations and recommended vaccinations, nutritious food, protection from the heat and cold through heated and air conditioned facility, and needed exercise.
- ❖ Provide for this puppy's emotional care. Under no circumstance is the dog to be used in dog fighting or similar activities, nor leave the dog unsupervised on a chain or leash.
- ❖ Never relinquish the dog to be placed in a pet shop, animal shelter, or similar establishment.
- ❖ Return the dog to Stellar Dobermans should the buyer be unable or unwilling to fulfill any of the above provisions, if the dog is orphaned, or if this dog is seized by any local authority as having been neglected or abandoned. Stellar Dobermans retains the right to reclaim this dog without compensation.
